Dear Family, Friends, and Venders:

The State of California recently passed legislation creating teams of representative from the State Board of Equalization of the State of California, who will be attending events such as Pow Wows, to check for Seller's Permits. Wildhorse must comply with this law.

We are mandated to require all venders to have and display their Seller's Permits. We also must keep a record of your Permit number on file. No vender will be permitted to set up unless they have complied with this law. We are requesting that all venders report their Permit number to us on the application form, provide us with a photocopy of the permit, and display it at all times during the Wild Horse Pow Wow.

If you do not have a State of California Seller's Permit, please call the State Board of Equalization at: 1(800)400-7115 and request an application package. There is no charge for a California Seller's Permit. If you do this by mail, it generally takes about two weeks to receive the permit.

You can also apply on line at their website, which is [www.boe.ca.gov](http://www.boe.ca.gov). Applying on line speeds up the process considerably.

We realize that complying with this presents more paperwork for all of you. However, we have been advised that it is very likely that a team from the Board of Equalization will be checking for permits.
